



# SASKATCHEWAN SENIORS MECHANISM INC. BYLAWS

# **June 2015**

### Preamble

WHEREAS Saskatchewan Seniors Mechanism (incorporated on July 24, 1989 under *The Non-profit Corporations Act*, Saskatchewan) and the Saskatchewan Seniors Mechanism Charitable Trust (incorporated August 16, 1995 under *The Non-profit Corporations Act*, Saskatchewan) amalgamated to form the Saskatchewan Seniors Mechanism incorporated as of June 20, 2011 under *The Non-profit Corporations Act*, Saskatchewan; and

**WHEREAS** Saskatchewan Seniors Mechanism is empowered under the said *Act* to make bylaws;

THEREFORE Saskatchewan Seniors Mechanism makes bylaws as follows:

# **TITLE**

Title

1. These bylaws may be cited as the *Bylaws of Saskatchewan Seniors Mechanism, Inc.* 

# INTERPRETATION

# **Definitions**

- 2. In these bylaws:
  - 2.1 "Mechanism" and "SSM" mean Saskatchewan Seniors Mechanism, Inc.
  - 2.2 "member organization" means an association of seniors which is non-discriminatory in relation to race, religion, sex, physical or mental abilities and which has been incorporated for at least two (2) years for the purpose of supporting and advancing the common interests of seniors.

# **OBJECTIVES**

# Aims and Purposes

- 3. To promote the well-being and independence of seniors in Saskatchewan by:
  - 3.1 Providing access to information and support services for seniors;
  - 3.2 Educating and training seniors regarding issues affecting them;
  - 3.3 Conducting research to identify issues affecting seniors, and solutions to address them.

# MEMBER ORGANIZATIONS

# Categories

4. Member organizations which may be represented on SSM may be province-wide, city-wide or area-wide in terms of membership, goals and objectives, and they will collectively provide a network of programs or services throughout the province.

# **MEMBERSHIP**

### Membership

- 5.1 Any organization that meets the definition of a member organization, pursuant to clause 2.2, and which has not been represented by any other existing member organization of SSM may apply for membership in SSM.
- 5.2 Every application for membership shall be subject to the approval of the Board of Directors of the SSM.
- 5.3 Any member organization may withdraw from membership in SSM by providing written notice to the Board of Directors of SSM.
- 5.4 After consultation with the member organization the Board has the right to revoke membership for just cause.

# **SUPPORTERS**

# Supporters

- 6.1
- 6.1.1 Notwithstanding the provisions of section 4 and subsection 5.1, there shall be a category known as "Supporters of SSM" which is open to any group or organization whose membership is composed primarily of persons who support and advance the interests of seniors.
- 6.1.2 Supporters of SSM may participate in activities of SSM but have no vote.
- 6.2 Every application to become a supporter shall be subject to the approval of the Board of Directors of SSM.
- 6.3 Any organization may withdraw from being a supporter of SSM by providing written notice to the Board of Directors of SSM.
- 6.4 After consultation with the supporter the Board has the right to revoke supporter designation for just cause.

# **DIRECTORS**

# Composition of the Board

- 7.1 The Board of Directors of Saskatchewan Seniors Mechanism shall be composed of twelve (12) members plus the Past President.
- 7.2 Directors, with the exception of the Treasurer, shall serve for no more than

two (2) consecutive two year terms of office in any one position. The Treasurer may serve up to four (4) consecutive two year terms of office.

7.3 The term of office of newly elected Directors shall take effect at the first meeting of the Board held after the Annual General Meeting of SSM.

# Duties & Responsibilities

- 8.1 Directors of SSM shall:
  - 8.1.1 Act honestly and in good faith, consistent with the best interests of SSM;
- 8.1.2 Exercise due care, diligence and skill that a reasonably prudent person would exercise in comparable circumstances, to work and provide sound stewardship of the SSM resources entrusted to them; and
- 8.1.3 Protect confidentiality on matters and information provided to them in confidence at all board and committee meetings.
- 8.2 Any director who acts in a manner inconsistent with the interests and reputation of SSM shall be deemed in conflict of interest and shall be re moved from the Board of Directors in accordance with the provisions of *The Non-profit Corporations Act*, Saskatchewan.

# NOMINATIONS AND ELECTIONS

*Officers* 9. The officers of SSM shall consist of the following:

- (a) President;
- (b) Vice-President;
  - (c) Secretary;
- (d) Treasurer; and
  - (e) Past President.

Vacancies

- 10.1 Except for the Past President, all officers and membersat-large shall be elected for a 2-year term at the AGM.
  - 10.2.1 Upon the prior approval of nomination by a member organization an individual shall be eligible to stand for election as an officer or member-at-large at the Annual General Meeting.
- 10.2.2 All nominations must be received by the Nominations Committee at least 30 days prior to the AGM.

- 10.3 The Past President shall chair the AGM during the election of officers and members-at-large.
- 10.4 Election of officers shall be conducted beginning with the position of President and then continue through Vice-President, Secretary and Treasurer. The person who receives the majority of votes cast (50% + 1) shall be declared elected. If there is no clear majority then a second and subsequent ballot(s) will be held until a clear majority is achieved. In subsequent ballots, the person with the least votes will be removed from the ballot. Individuals who are not elected to one position are eligible to run for other positions.
- 10.5 Elections for members-at-large shall occur following election of officers. Members-at-large will be elected on a single ballot. Those receiving the highest number of ballots will be deemed elected (up to the required number of members-at-large). In the event that any terms are only 1 year in duration the elected member(s)-at-large with the lowest number of votes will serve out the remainder of those terms.
- 10.6 Where an officer vacancy occurs, such vacancy shall be filled by and from the Board of Directors to complete the term.
- 10.7 Where a member-at-large vacancy occurs the Board of Directors may fill such vacancy to complete the term.

# Removals & Expulsions

11.1 The Board of Directors of SSM may remove any officer by a two-thirds (2/3) majority vote of the directors whenever, in the judgement of the Board, the best interests of SSM would be served.

# OFFICERS AND THEIR DUTIES

### President

- 12.1 The President shall:
- 12.1.1 Assume his/her office immediately upon election.
  - 12.1.2 Be the principal executive officer of SSM and it shall be his/her duty to be vigilant and active in promoting the objectives of SSM;
  - 12.1.3 Generally supervise and control the business and affairs of SSM;
  - 12.1.4 Keep the Executive Committee and the Executive Director aware of all undertakings carried out on behalf of the Board of Directors;
    - 12.1.5 Preside at all meetings of the Board of Directors and the Executive Committee:
    - 12.1.6 Be an ex officio member of all committees; and

12.1.7 Perform such other duties which may, from time to time, be prescribed by the Board of Directors.

### Vice-President

- 13.1 The Vice-President shall:
- 13.1.1 Assist the President in the performance of presidential duties and shall act as President *pro tempore* in the absence or inability of the President; and
- 13.1.2 Perform such other duties which may, from time to time, be prescribed by the Board of directors
- 13.2.1 The Vice-President shall automatically assume the office of President when the present incumbent is permanently unable to carry out his/her duties.
  - 13.2.2 The completion of the term of office referred to in clause 13.2.1 shall not be considered as a term of office of President.

### Treasurer

- 14. The Treasurer shall:
  - 14.1 If required by the Board of Directors, be bonded for the faithful discharge of his/her duties in such sums and sureties as the board may determine;
  - 14.2 Be responsible for ascertaining the correctness of the financial status of SSM;
    - 14.3 Report the financial status of SSM at all board meetings;
  - 14.4 Perform all other duties incident to the office of Treasurer; and
  - 14.5 Carry out such other duties as may be assigned, from time to time, by the Board.

# Secretary

15. The Secretary shall attend all meetings of the Board of Directors and shall ensure that minutes are kept.

# **CONDUCT OF BUSINESS**

# Management

- 16.1 Official cheque signing authorities shall be any two of the executive director, president, treasurer, vice-president, and secretary of SSM.
- 16.2 As designated officers of the Board, Bylaw 16.1 shall apply to the signing of any deeds, mortgages, loans, contracts or other instruments which are authorized by the Board to be executed.

# Voting Authority

- 17. Each director present at a meeting of the Board of Directors shall have one vote.
- Meetings
- 18. There shall be at least four (4) meetings of the Board of Directors in each fiscal year.
- Fiscal Year
- 19. The fiscal year of SSM shall commence on April 1of a year and end on March 31 of the following calendar year.
- Quorum
- 20. A majority of voting Directors personally present at a meeting of the Board of Directors shall constitute a quorum.

# Conduct of Meetings

21. Where not otherwise expressly provided for in *The Non-profit Corporations*\*\*Act, or elsewhere in these bylaws, the conduct of meetings of the Board of Directors shall be governed by the latest revised edition of \*\*Roberts Rules of Order.

# **COMMITTEES**

### Committees

- 22.1 The following standing committees shall be struck at the first meeting of the Board after the Annual General Meeting of SSM:
  - 22.1.1 Governance Committee chaired by the Vice President;
- 22.1.2 Finance and Audit Committee chaired by the Treasurer;
  - 22.1.3 Membership Committee chaired by the Secretary:
  - 22.1.4 Nominations Committee chaired by the Past President; and
- 22.1.5 Other Task Groups as needed to carry out the work of SSM.
- 22.2 The Board of Directors may appoint committee members from the members of the Board or may appoint participants from the general membership of any member organization(s).
- 22.3.1 There shall be a committee known as the Executive Committee which shall consist of the:
  - (i) President:
  - (ii) Vice-President:
  - (iii) Secretary;
  - (iv) Treasurer; and
  - (v) Past President.

- 22.3.2 The Executive Committee shall have the authority of the Board of Directors of SSM as circumstances may dictate, but all actions of this committee shall be subject to the approval of the Board at the next Board meeting.
- 22.4 The Board of Directors may establish *ad hoc* task groups as may be re quired, and appointments of members to these task groups shall be rati fied by the Board.

# STAFF OF SSM

# Executive

23. The staff position of Executive Director of SSM shall be **Director** an **ex officio**, non-voting member of the Board of Directors and of each committee.

# Support Staff

24. The Board of Directors may engage such other support staff as may be deemed necessary to carry out the day-to-day functions and operations of the SSM office.

# **ANNUAL GENERAL MEETINGS**

# Annual General Meeting

25. The Annual General Meeting of SSM shall be held within three (3) months of the end of the fiscal year, and in no case shall it be held later than June 30.

# Voting Delegates

- 26. 1 Except as provided in section 29, each member organization shall appoint in writing, the names of three (3) voting delegates for the nual General Meeting.
- 26.2 All members of the SSM Board of Directors have a vote at the Annual General Meeting.

# Proxy Voting

27. Where a voting delegate representing a member organization is unable to attend, an alternate may be named by the organization. This notification shall be made in writing to SSM.

### Quorum

28. A simple majority of voting members personally present at the opening of the Annual General Meeting of SSM shall constitute a guorum.

# **BYLAWS AND AMENDMENTS THERETO**

Directors may make, Amend or Repeal Bylaws


29.1 Voting Delegates of member organizations may, by a twothirds (2/3) majority at the Annual General Meeting by resolution make, amend or repeal any bylaws that regulate the activities and affairs of SSM **as per terms of 'The Non-Profit Corporations Act"**.

- 29.2 The Board of Directors or any Voting Delegate may submit any Proposed bylaws or any amendments or repeal thereof to the voting delegates at the Annual General Meeting by giving 45 days notice in writing. The delegates may, by resolution confirm, reject or amend the proposed bylaws, amendments or repeals in accordance with 29.1
- 29.3 A bylaw, an amendment to a bylaw or a repeal of a bylaw shall be effective from the day of approval at the Annual General Meeting.

# WIND-UP AND DISSOLUTION

Wind-up & Dissolution

In the event of the wind-up and dissolution of the Saskatchewan Seniors Mechanism, all the property and assets shall, after the payment of all liabilities, be distributed to one or more qualified donees, and in accordance with the provisions of *The Non-profit Corporations Act*, Saskatchewan.



# **President's Report**

# Saskatchewan Seniors Mechanism 2017 Annual General Meeting

2016 – 2017 has been a busy and productive year for SSM. Some of the year's highlights are:


- The September Board Orientation was an opportunity to welcome and acquaint new Board members with SSM procedures and structures and for the Board to set goals for the year.
- We bid a fond farewell to Program Coordinator Rosemary Flaman and welcomed her replacement Michel Sorensen as well as Media and Ageism Coordinator Linda Anderson.
- Held a Town Hall Meeting on a potential Canadian Health Accord together with three of our organizations.
- Met with the House of Commons Standing Committee on Finance at their request. We raised issues on Age-Friendly Communities, Home Care, pensions and a National Pharmacare Program.
- Met with the House of Commons Standing Committee on Operations and Estimates regarding possible changes to Canada Post mail delivery.
- We continued to meet with the Ministry of Health on a regular basis, putting forth issues of concern to seniors. We also met with Minister of Health, the Hon. Jim Reiter.
- Following the provincial election, we were invited to attend a roundtable on accessibility to voting and to participate in a focus group to identify observations regarding the federal election.
- We requested and received approval for Caregivers Week, March 19 25, 2017.
- Revised the Frauds and Scams Handbook in collaboration with the Saskatchewan Safety Council, Saskatchewan Business Bureau, R.C.M.P., Crime Stoppers, Regina City Police and the Financial and Consumer Affairs Authority.
- Continued to encourage and promote Age-Friendly communities and created a Saskatchewan resource, in both French and English, as well as a video for use in Age-Friendly communities presentations.
- Monitored Saskatchewan media to assess ageism in the media.
- Committees each met regularly to plan and execute their committee tasks.
- The Governance Committee drafted a template for committee mandates, a number of which were presented to the Board for approval. Included were Board Duties and Responsibilities, job profiles for the Executive Director and for Board Officers. Several policies were also approved: Hours of Work, Stat Holidays, Vacation Leave, Sick/Compassionate Leave, Travel and Expenses, Equal Opportunity, Termination of employment. Governance continues as "work in progress".
- Accepted Association of Personal Home Care Operators of Saskatchewan as a Supporter Organization.
- Developed a new Vision Statement: "Quality Life for All Older Adults in Saskatchewan".

- An Age-Friendly resource currently available in both French and English is in place and an Age-Friendly Brochure is currently available in English with a French version in the works.
- Member Organization Consultation once again provided an opportunity for SSM and organizations under its umbrella to consult with one another and to exchange information on work being done in the respective organizations.
- Presented Volunteer Awards to celebrate seniors.
- Distributed \$97,970.00 to member organizations for activities and programs as outlined in their grant applications.
- Hosted another successful four western provinces Age-Friendly consultation.
- Received the Better Business Bureau of Saskatchewan Torch Award for an ethical nonprofit organization.

Thanks to Board members Randy Dove, Margaret Gailing, Brian Harris, George James, Les Lye, Wilma Mollard, Louise Nichol, Andre Nogue, Nancy O'Donnell-Monk, Sunil Pandila and Mae Wesley for your hard work to ensure the continued success of SSM. Thanks also to our capable staff Linda Anderson, Lynne Cousins, Holly Schick, Michel Sorensen and Beth Stilborn for your diligence and support.

# **Executive Director's Report**

# Saskatchewan Seniors Mechanism 2017 Annual General Meeting

SSM continues to be a dynamic, growing organization. I am pleased to share some of the work of the past year with you. More detailed reports from our committees and on some of our programs and partnerships are included later in this book.

Our annual conference took place on June 1-2 in Yorkton. The theme was *Alone or Lonely? - Seniors and Isolation*. Speakers included Suzanne Allen, New Horizons for Seniors speaking about Why We Need to Focus on Addressing Social Isolation of Older Adults and Ways Social Isolation of Older Adults is being Addressed; Nuelle Novik, Research Faculty, SPHERU speaking about Rural Older Adults and the Impacts of Social Isolation; Joanne Bracken, Alzheimer Society of Saskatchewan speaking about Dementia and Isolation; Rob Cozine, speaking about Saskatchewan Crime Stoppers; Yvette Crane and Sandra Leitch from the Red Cross speaking about their Friendly Visiting Program; and Linda Restau and Bernie Gibson from the Community Care Branch sharing an Overview of Programs and Services for Older Adults. We also heard from communities that have been involved in pilot projects around reducing isolation in rural communities, and we introduced the resource we created as part of the Seniors and Isolation project. There were also displays and time for participant discussion and input.

Our **Annual General Meeting** was held in June following the annual conference. We elected four new Board Members – Mae Wesley, Suniel Pandilla, Nancy O'Donnell-Monk, and George James. Our Board Members continue to be eager and committed to attending meetings and getting involved with various committees and task groups.

We have received funding for Creating Inclusive Communities – which includes ongoing work on Age-Friendly Communities, work on media and ageism, and elder abuse – through a New Horizons Pan-Canadian Contribution Agreement. We are working with the Alzheimer Society, the Red Cross, Saskatchewan Population Health and Evaluation Research Unit, the Lifelong Learning Centre and the Fédération des aînés fransaskois as part of an overall impact plan collaborative and each of us has one or more projects that we will be working on.

In August we completed our project on **Seniors and Isolation** funded through New Horizons. As part of this project we developed a resource that can be used to offer programs for seniors in rural communities. We worked with the communities of Hanley, Lumsden and Strasbourg to pilot ideas. We are very pleased that all three pilot projects continue to be very active and successful in getting more older adults out to events in their communities. One of the interesting learnings seems to be that the key factor in getting something happening in these communities is the initial focus group meeting where people are given an opportunity to think about their community,

who they need to reach out to, and have a chance to think about some ideas of how to get things going and the types of activities they could look at. This seems to provide a kind of jump start to get things going in the community.

We had no difficulty in getting active senior volunteers willing to take the lead in getting things happening in their community. Not only are more seniors out and involved, but we strengthened the community senior volunteer leadership which is the key to keeping things happening.

We published our book, *A Century of Memories*, which contains stories we received from people 90 years of age and older. We printed 500 copies and have sold approximately 450 so far.

We had a very successful **Member Organization Consultation**. This brought together approximately 35 people from the member organizations to share what work they are doing, learn more about what SSM is doing, and discuss ways we can work together.

We continue to do presentations on **Fraud Awareness** and continue to supply Handbooks to various groups including libraries, police, superannuated teachers and seniors groups. We have worked with the Better Business Bureau, Sask. Safety Council, Financial and Consumer Affairs, and Crime Stoppers to update, expand and reprint the handbook as "Fraud Prevention and Safety for Individuals". The revised edition is now available.

**Senior Neglect and Abuse Victims Response Line** – We completed a small research project through the Community Research Unit at the University of Regina. The research is on the available services and gaps, in Regina Qu'Appelle Health Region, for victims of senior abuse and neglect.

This year we welcomed one new **Supporter Organization** – The Association of Personal Care Home Operators in Saskatchewan.

We worked with the Fédération des aînés fransaskois and the Alzheimer Society of Saskatchewan to host a roundtable discussion on the possibility of starting a **caregiver respite program** here in Saskatchewan that could be similar to the Québec program, Baluchon Alzheimer. Guylaine Martin, Executive Director of Baluchon Alzheimer, spoke about the Québec program and participated in the discussion. We continue to work on this exciting possibility.

We were pleased that Minister Reiter responded positively to our request to have a week in March declared **Caregivers Week**. We put some basic ideas for the week on our website. We are planning to make the same request next year and to have additional resources for it. Sask. Health made sure the information about the week was distributed through their networks and made available on their website.

We worked with the National Association of Federal Retirees, the Canadian Medical

Association, the Saskatchewan Union Retirees Federation and the Regina Branch of the Superannuated Teachers of Saskatchewan to host a **Town Hall on the Canada Health Accord and Older Adults**.

We worked with the Mooshum and Kookum program on an **Aboriginal Fitness Project** to provide fitness opportunities for older aboriginal adults in Regina. They purchased and used passes to the Lawson/Fieldhouse.

We have continued with our **Seniors Information Phone Line**.

Because SSM is a partner in the **Sask 211** project, we continue to offer input on possible issues and improvements that could better meet the needs of older adults.

We installed a new **phone system** in our office. Our old phones had been around for several years and we didn't have really good phones for a couple of the staff. The new system has additional features we are making good use of.

We have hired **two new staff people**. Michel Sorensen is our new Program Coordinator, replacing Rosemary Flaman who retired and moved to Alberta. Linda Anderson has been hired to work ½ time for three years on the Media and Ageism project. Both are proving to be excellent additions to our staff team.



We have established a **Communication Committee** which will work on our overall communication with member organizations and the wider community, including having oversight of Gray Matters and all advertising. # **Age-Friendly Saskatchewan**

The Age-Friendly Saskatchewan Committee continues to progress by presenting to and supporting Saskatchewan communities as they journey toward becoming more age-friendly. The Committee has presented to over 20 communities. New connections have recently been made with Rosetown, Strasbourg, Meadow Lake, Nokomis, Humboldt, Tisdale, Swift Current, Regina, Fort Qu'Appelle, Indian Head, Weyburn, Radville, Bulyea and Pasqua First Nation. We have begun tracking communities in order to ascertain where each is in their age-friendly journey.

New Horizons Pan Canadian Grants funding is in place for creating inclusive communities, including work on Age-Friendly communities, media and ageism, and elder abuse. We are working with the Alzheimer Society, Red Cross, Saskatchewan Population Health and Evaluation Research Unit, Lifelong Learning Centre and the Fédération des aînés fransaskois as part of an impact plan collaborative.

This past winter, we held a gathering with representatives from communities involved in the age-friendly initiative where we shared what communities are doing with respect to age-friendly as well as ways to address challenges. It was a great opportunity to learn from one another. Similar gatherings are planned in different areas of the province.

SSM is also working to reduce isolation through age-friendly communities. In order to do so, we recently tested out an idea in the communities of Strasbourg and Bulyea with a seniors and school children pen pal project that involved 26 seniors and 22 students. This culminated in a windup on March 10, 2017 when a potluck lunch was held for seniors and students, involving other community members, the school division literacy coordinator, the school principal and the president of SSM. This brought to the fore the intergenerational aspect of Age-Friendly. Project evaluations were very positive and seniors were unanimous in their belief that it reduced their isolation by better connecting them with the community. The experience was documented in our *Gray Matters* publication with the goal of encouraging other communities to try something similar.

Currently, we are in the process of developing a resource for measurement and evaluation of communities to determine their progress toward age-friendly milestones in order to be able to recognize them as having done so. As well, we are working on a resource for businesses to help them understand and work toward becoming age-friendly. The resource is meant to be used by any business in any community, but will be introduced in the particular communities with which we are working.

Our SSM Executive Director continues to be part of the PHAC Age Friendly Communities erence Group.

Our Age-Friendly Communities Video has been completed and we are now starting to use it as a way of sharing what some communities (Regina Beach, Buena Vista, Moose Jaw, Ponteix, Strasbourg, Saskatoon, Prince Albert, Pasqua First Nation) are doing to reduce isolation of older adults by creating healthy, accessible, inclusive and safe communities where seniors are valued, included and supported. Hopefully, this will encourage more communities to be involved.

Again, SSM hosted a Western Provinces Roundtable on Age-Friendly Communities with representatives from the four western provinces attending. Also attending was Ramona Furkert from the Ministry of Health. Excellent sharing of information and ideas took place. The group is becoming more cohesive and intends to find ways to stay in touch over the coming year.

# Media and Ageism

The Media & Ageism committee is somewhat amorphous as volunteers with particular skills are needed for specific phases of the Media & Ageism project. For the first year members reviewed and edited the materials that were used for the media monitoring phases. Most also took part in the monitoring. Some members were kept informed but will become more active in the second phase of the project which includes the planning and implementation of outreach with the media and awareness raising with the public.

As part of the Creating a Culture of Inclusion plan, Media and Ageism planned and implemented the Media Monitoring research which took place in the second and third weeks of February, 2017. Approximately 35 communities' newspapers and/or other media were monitored. While the original group of monitors totalled 65 people, some monitors were unable to complete the task because of various life events. Those who monitored radio found an amazing lack of any stories about or affecting older adults.


Media Monitoring research has gathered the raw data about the the kinds of stories about older adults and the roles they play in the news. Data also will reveal where the voices of older adults are ignored even when the subject has implications for them. Qualitative monitoring found data on stories that were age positive or conveyed an ageist message, subtly or blatantly.

During the summer of 2017, with the help of the Saskatchewan Public Health Evaluation and Research Unit, I will work with Angela Culham, a graduate student research assistant. Angela will scan back copies of rural newspapers that were not monitored and add quantitative data from that source to our collection. She will then use her experience and skills to collate and record the data, do analysis and write research reports that will identify the reality of the media coverage for that period in February.

From September 2017 to October 2018, the Media and Ageism committee members and other consultants will plan and implement outreach to professional journalists and media management in various locations in south and central Saskatchewan. Outreach will include awareness raising and training using print, AV and social media objects. Using these resources and intentional publicity initiatives will also contribute to awareness raising with the general public.



#### 2016 Achievements

Strong rapport has been established with our partner, Saskatchewan Seniors Mechanism, for over 17 years and has resulted in an increase in referrals and activations. Executive Director, Holly Schick has given me the opportunity to present new innovations from Philips Lifeline and distribute marketing material to board members. SSM office staff, Holly, Lynne, Beth and Michel continue to refer people in need of the service via phone, email, and walk-ins as well as promoting our service at all events they attend. SSM board members and their organization members have also referred clients to the Lifeline service resulting in installations. I attended the SSM's Annual Conference in June 2016 in Yorkton and I will attend 2017 SSM Conference in June in Regina. This will give me the opportunity to educate new attendees as well as update existing ones on the standard Lifeline service as well as introduce them to the new PMD and refresh the GoSafe mobile service. One page ads in Gray Matters Newsletters in all quarterly editions and our upgraded link to the SSM webpage have given Lifeline increased exposure and installations. I am proud to educate people in my travels about the value of the SSM and to support the SSM with partnership fees and rental fees paid quarterly.

**Ongoing:** Continue to build rapport with VAC (Veterans Affairs Canada) with sales calls and updates in Regina office only to 1.5 client service agents— this has drastically reduced the number of referrals of vets to Lifeline.

Royal Canadian Legion- continue to build rapport with the 244 Legions in SK replenishing in my travels throughout SK and quarterly direct mail outs from Toronto office. Since Philips Lifeline's partnership with the Royal Canadian Legion nationally in Jan/08 Lifeline continues offering the legion members 2 months free for the Lifeline service for themselves, family, or friends. Lifeline had a display at their conference in Prince Albert in Oct 2015 and next one scheduled for 2017.

I attended and had display booths at numerous national, provincial and local

conferences, and education days for a variety of healthcare professionals- SAOT (SK Association of Occupational Therapists), SRNA (SK Registered Nurses Association), Diabetes Association Tradeshow, Nurse Practitioners.

Displays at numerous conferences and trade shows locally and provincially, attended primarily by seniors' organizations, seniors and their families/caregivers but also healthcare professionals





#### **Background Information:**

Age-Friendly Communities encourages older adults to be involved in decision making in their communities, and encourages government leaders at all levels to take seriously the opinions of older adults.

Addressing the current provincial deficit is important. However, it is equally important to ensure that the needs of the people of Saskatchewan, particularly the most vulnerable, are being met. Our measure as a society comes from our ability to provide for a good quality of life for our citizens. Not all decisions can be made based on financial cost – the cost to our physical, mental and spiritual health must also be taken into account.

#### Funding for health care services

Good health is key to being able to live a full and active life. To maintain good health requires access to a variety of services as part of our health care system or at affordable costs.

Many older adults have fixed incomes not protected from inflation and cost increases. The recent provincial budget has made significant changes to funding that may affect the health and wellbeing of older adults and others.

Included in the changes are:

- Increased long term care charges
- Loss of funding support for chiropractor services
- Loss of support for hearing aid and podiatry services
- Introduction of PST on health insurance premiums
- Uncertainty about service levels with the merger of the health regions

#### Loss of STC Bus Service

Transportation is an essential service for people to allow them to access services, participate in the life of their communities, and stay connected with family and friends. Transportation needs change for many older adults. Driving may be restricted. Mobility issues may affect walking. Connecting to services requires affordable, appropriate transportation. With STC service no longer available, how will the provincial government address the need to provide the valuable services STC has offered? These include:

- Transportation to appointments e.g. medical
- Transportation to access services only available in another centre
- Accessible, affordable transportation, particularly for people in rural communities
- Freight service e.g. cancer medications to be administered locally for those too frail to travel
- Transportation of library books for the interlibrary loan system
- Providing the sole public transportation option in many areas

#### **Reduction in Funding for Library Services**

Older adults can become isolated due to ageism, chronic health problems, lack of transportation, low income, living at a distance from family, and critical life transitions. Libraries provide a valuable service that assists in reducing isolation of older adults. Library materials help older adults stay connected with current issues in the world, and provide a source of education and entertainment. Libraries are places where older adults can learn about and try out technology. Local libraries often provide programming that helps build stronger community connections for older adults and others.

#### Increases in PST

For older adults on low and/or fixed incomes, increases in the costs of goods and services can have a significant effect on their ability to access some of the things essential to their lives. It can also mean having to cut back on the sort of activities that help increase their quality of life.

#### **Reduction of Hospital Chaplaincy Services**

Overall health and wellbeing includes access to spiritual care. People in hospitals, and their family, are usually stressed and often facing a time of crisis in their lives. Some of these people are not regularly associated with any faith community, or may be a long way from their home faith community. Government supported chaplaincy services ensure that spiritual support is available to all people in hospital and their families. Government supported chaplaincy services also help to provide the listing of names of those in hospital who want spiritual care from local faith visitors.

#### **Reduced Funding for Communities**

Strong communities ensure a healthy population and high quality of life. The loss of SaskPower and SaskEnergy payments in lieu from local communities has left many communities struggling to address this reduction in resources. The shortfall in funding to communities is likely to result in:


